## Slippery Rock Parks & Rec Parent Information

#### Pre-K Schedules (Ages 4-5):

The Slippery Rock Parks & Recreation Pre-K program is designed for children ages 4-5. This 9-month program meets four days a week, Monday through Thursday. Payment for the program is made on a monthly basis and details can be found in the registration packet. Parents are required to sign a Parent Contract/Payment Contract and submit it along with the registration paperwork. Thank you for considering our program.

### FLF Schedules (Ages 3-4, MUST BE POTTY TRAINED):

The FLF program offered by Slippery Rock Parks & Recreation is designed for children aged 3-4 years. This program runs for a duration of 9 months, operating on a schedule of 3 days per week, specifically Tuesday through Thursday. Participants are required to make monthly payments as outlined in the registration packet. In order to enroll in the program, parents must sign a Parent Contract/Payment Contract and submit it along with the registration paperwork. Thank you for considering our program.

#### **EXTENDED DAY:**

The Slippery Rock Parks & Recreation Extended Day Program is a voluntary option available from 12:00PM to 2:00PM on Tuesdays through Thursdays. This program offers additional structured play and learning opportunities for children at the end of the day, with activities based on a designated theme for each week. Themes are selected monthly and vary from month to month. Payment for the program is on a monthly basis, with flyers distributed in the children's take-home folders. Pricing details are included on the flyer and may vary depending on the number of days in each week. Please note that this payment is separate from the students' tuition fees.

#### **ORITENTATION DAY:**

Orientation will take place the week before school starts! It will be on Tuesday August 27th, 2024. School will start on Tuesday September 3, 2024 due to the holiday. Orientation information will be sent out to those registered on August 1, 2024.
