### 1. FEE REQUIREMENTS:

Payment must be received at time of registration.

### 2. PROHIBITED ACTIVITIES:

Violations of these prohibited activities could result in future loss of renting our facilities, any charges incurred as a result of violating rules, which includes but is not limited to; damage to facility, any cost incurred due to negligence or disregard to the following activities:

- ALCOHOLIC BEVERAGES in the building or on the grounds.
- NO SMOKING permitted on Park Property.
- NO DISORDERLY CONDUCT requiring emergency control.
- NO DISTURBANCE OF SYSTEMS: Fire Control, Smoke Control, Security System, Electric System
- NO PHYSICAL DAMAGE to the building and contents or loss of accommodations.
   Use of additional rooms, without renting and/or knowledge of the office personnel.

#### 3. USER POLICY:

- A Rental Agreement must be signed by the individual renting the building.
- ALL REQUIRED FEES must be paid at the time of signing. We will not hold a
  date. Hours of rental agreement 7am-10pm.

#### 4. KEY:

The key to the Recreation building must be picked up prior to the day of the event. Every effort will be made to contact you as a reminder, but it is your responsibility to contact the Park office and make arrangements to pick up the key. Keys must be picked up Monday through Friday, between the hours of 7:30 a.m.-3:30 p.m. The key is to be deposited into the drop box, located on the office door.

#### 5. BUILDING:

 All children <u>MUST</u> be supervised in the restrooms. Children are to be supervised by Adults/Parents at <u>ALL TIMES</u>!

# I understand and do hereby agree that:

- 1. Only those individuals authorized by the sponsoring organization shall be permitted in the building.
- 2. Individuals involved in the activity are limited to the use of area indicated. Parents and adults are responsible for their children's behavior.
- 3. The Recreation Center key must by picked up at the Park Office, Mon.-Fri., 7:30-3:30PM. Return the key by depositing it in the mail slot
- 4. NO ALCOHOLIC BEVERAGES ARE PERMITTED IN THE PARK.
- 5. The User Agency and the individuals participating in the program sponsored by the User Agency at the Slippery Rock Area Park & Recreation do hereby agree to indemnify and hold harmless from any liability whatsoever arising from the use of the Slippery Rock Area Parks & Recreation, the Slippery Rock Area Parks and Recreation board, its Individual members, the Borough of Slippery Rock, the Slippery Rock Township & The Rock School Slippery District.
- 6. Reservation will not be accepted until this form is returned to this office.
- 7. Any party wanting to charge admission to their function must provide proof of a one million dollar insurance policy. The party will not be permitted to charge if this proof of insurance is not provided.
- 8. The Rec Center can be rented until 10pm.
